Councilman Schirmer – gave the Water & Sewer report for May 2016

Councilman Costello – Chief gave the monthly report and Councilwoman Thornton complimented Officer Mills for solving the missing row boat. Greg Chorvas added that the Stallions are off to a roaring start. Summer Rec starts July 5th. During the gun show held at the ice arena, there were two larcenies but they were caught because of the security cameras.

Councilman Bruno – Boys & Girls Club held their annual auction and they raised \$58,000.00 this year, it was a great night!

Motion made by Councilwoman Thornton, seconded by Councilman Costello to approve the resolution, as on file, to adopt the NYS Unified Solar Permit and to apply for Consolidation Funding Application (CFA) funds.

Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilman Bruno to approve the resolution, as on file, authorizing the Chief Executive Officer to sign an agreement on behalf of the town which authorizes the superintendent to directly contract with the superintendents or persons holding similar public office in other municipalities who possess similar authorization for the borrowing or lending of materials and supplies and the exchanging, leasing, renting of machinery and equipment, including the operators thereof, for the public of aiding the superintendent in the performance of his/her duties, per the recommendation of the Highway Superintendent.
