will meet. Transportation meeting will be on January 25th at 6:30 p.m. Historic Preservation will meet on January 23rd at 7:00 p.m. regarding Winston Farm. January 24th the League of Women Voters will be hosting a presentation on Winston Farm at the Senior Center.

Councilman Costello – work on parking lot behind town hall will resume in the spring, but have seen improvement on drainage already. Warehouse work for the new offices has begun and hopefully next week a new floor will be poured. Attendance at the Ice Rink has been very strong.

Councilwoman Campbell – Building Inspector's report given, complete report on file in the Town Clerk's Office. Attended Planning Board last night and there was a lot of discussion and public comments on HITS public hearing. Councilman Costello, the Mayor and self participated in telephone conference with attorneys regarding Casino – resistance is best at this time.
