System we have now does not share information with any other agency.

They have had the DOS-base New World system since 1994 and is linked with other agencies, such as: County 911, State Police and other local police departments. This would eliminate phone calls, radio communication and acts real time. GPS is included. It is "free" but there would be a packet-cluster licensing fee.

# **MOTIONS & RESOLUTIONS:**

Motion made by Councilwoman Thornton, seconded by Councilman Costello to approve the following resolution, as read, dealing with the Saugerties Transportation and Land Use Project:

WHEREAS, the Town of Saugerties, the Village of Saugerties, the Ulster County Transportation Council and New York State Department of Transportation-Region 8 worked cooperatively over a two year period to analyze present and future transportation and land use issues in the town and village and develop recommendations to improve all modes of transportation and consider transportation improvements that preserve and enhance the quality of life in the area; and

WHEREAS, the Saugerties Area Mobility Analysis (SAMA) Report recommendations were developed through an extensive public participation process that included public meetings and an Advisory Committee to reach a consensus; and

WHEREAS, the Advisory Committee for SAMA included members appointed by the town and village boards, UCTC staff and NYSDOT; and

WHEREAS, the SAMA recommendations include ten priority areas and associated projects that address capacity, safety, and quality of life for all modes of transportation including highway, transit, bicycle and pedestrian; and

WHEREAS, the SAMA recommendations include the adoption of an access management overlay zone, to be adopted by the Town of Saugerties in order to improve safety, capacity and operations of the existing highway system and

WHEREAS, the town and village will form a Transportation Implementation Committee to implement the recommendations with the assistance of the NYSDOT and the UCTC; and

WHEREAS, the town and village will examine their Comprehensive Plan, Zoning and other Land Use Controls for needed amendments to ensure that the recommendations of the report are considered as part of their land use decisions and capital investments:

NOW, THEREFORE, BE IT RESOLVED THAT THE TOWN BOARD OF THE TOWN OF SAUGERTIES SUPPORTS THE RECOMMENDATIONS OF THE SAUGERTIES AREA MOBILITY ANALYSIS REPORT.

Discussion: Councilman Costello stated that Malden has experienced extreme flooding and hopefully this will rectify the situation.

Motion made by Councilman Costello, seconded by Councilwoman Campbell to approve the first payment of \$10,000.00 from the Town of Saugerties to Bob Imbierowic, carousel owner, for the town to purchase the carousel located at the Beachview Center on Partition Street in Saugerties, New York.

Discussion: Councilwoman Campbell stated that this is a good investment and partial money will come from the recreation trust fund and those fees have been paid by developers so it's not taxpayer money and believes it will make money in no time. It will be money well spent. Supervisor Helsmoortel talked to curator in NYS museum and this carousel is in great working order and believes that we should "invest in the past to preserve the future".
