Mr. Francello questioned Win One for Jesus on the definition regarding infirmed, the receiving of personally care, supervision and services and the funding.

Mr. Mahon explained the home was for women who were infirmed with infirmed meaning needing personal care, supervision and services. They were exempt from state licensing and they had a 501(c)(3) exemption from the Internal Revenue Service so they are able to collect funds as any not-for-profit organization.

The board had received a copy of the Provisional Certification Certificate from Teen Challenge dated September 2008.

Clients might be able to apply for social services.

There would be 1 staff on at night, 2 or 3 during days and 1 or 2 evenings.

Clients would be allowed supervised visitation

Random drug test would be done. Will have a no tolerance policy. Positive testing would mean transfer to another program

Clients would stay 6 months to 1 year. Woman could have a child between 0 and 3 years of age.

Winning Circle is a separate program, non residential.

They have been going to local courts to get known as an organization that helps women. And they are becoming known with county services.

Jeanne requested something in writing from OASAS stating Win One for Jesus does not need a license.

Public hearing closed on Motion of Jeanne seconded by Joe M. with the understanding that as soon as Mr. Mahon receives information from OASAS or finds something in his file he would forward it immediately. 5/0
