PUBLIC COMMENT PERIOD:

Angela Gaffney-Smith – voice concerns over the Gun Show being held at Cantine Field in June - inappropriate venue. The Right to Bear Arms is for individuals not for businesses to make money. We need ways to separate children and sale of guns in a town park.

Pete Kramer – also feels it is not appropriate to hold a gun show near so many areas for youth activities. We should discourage this in the future.

Warren Ferine – neighbors are making unbelievable noise with music and the summertime will be worse. We need a noise ordinance. As soon as the police leave, they start playing the music again.

Ron Marchuk – neighbors should show respect to each other and not play music so loud; a noise ordinance would be nice.

Austin Hagan – would like bikes allowed in the skate park. Worked on getting skate park to fruition. Investigated the Town of Saugerties skate park and should be durable to bikes as well as skateboards. Would like consideration for bikers. Councilman Costello – compliments to Supervisor Helsmoortel and the board for effort on getting emergency vehicle in place. Thank Doug Myer for working on drainage issues at town hall. Boat ramps are installed. Delivery of lights and poles have happened for Dutchmen field. Congratulations to KJ Swart for award with help of apprehending bank robber. Congratulations to Nancy Campbell for the mural installed at town hall.

Councilman Bruno – have been close with Josh since taking office and he didn't let politics come in play – will miss him. EDC interviewing web designers. Read Building report for April 2014 and read MS-4 report, both are on file at the Town Clerk's Office.

MOTIONS & RESOLUTIONS:

Motion made by Councilman Schirmer, seconded by Councilwoman Thornton to appoint Samantha Wamsley to the position of part time Deputy Receiver of Taxes at current rate of pay, effective immediately.

Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilman Bruno to approve that the Police Department will no longer be an issuing agent of parking permits for people with disabilities and the Town Clerk will assume the role. The Town Clerk, Lisa A. Stanley at 4 High Street in the Town of Saugerties will be the issuing agent. The Town Clerk's phone number is 845-246-2800 ext. 343 and fax number is 845-246-0127. The intended length of permanent permit issuance will be five years.

Motion made by Councilman Bruno, seconded by Councilman Costello to approve the resolution, as on file, pertaining to bridge repair relating to the highway department.

Discussion: Councilman Bruno said the highway department received a quote of \$5,700.00 for bluestone to be picked up.

Motion made by Councilman Schirmer, seconded by Councilman Bruno to approve the resolution, as on file, pertaining to acquiring real property located in Bluestone Park from the County of Ulster SBL #28.4-7-19 and 28.4-7-56.

Discussion: Councilman Schirmer explained that the property was eligible for tax sale but the county took it off. When the special district is formed, the burden will go to the residents using the water.

Motion made by Councilman Schirmer, seconded by Councilman Bruno to approve the resolution, as on file, regarding appropriating money to pay the costs of preparing a general map, plan and report for providing water facilities and services to Bluestone Park in connection with the possible creation of a Bluestone Park water district in the Town of Saugerties.
