**Greg Chorvas,** *Superintendent of Buildings & Grounds* – James Harris' Eagle Project at Jaycee Field is nearing completion. Michael DeRuyter's Eagle Project has 1.2 miles of trail complete; we are finalizing the trail grant to send to the State. Also, female changing rooms at the Ice Rink are close to completion.

## **BOARD COMMITTEE REPORTS:**

**Councilman Macarille** – Building Department reviewing applications for new building inspector. Ron Biscoe has not yet completed demolition of home on Old Route 32 in Quarryville. Glasco Mini Park boat ramp has had the Army Corps of Engineers sign-off on permits and work can get started.

**Councilwoman Thornton** – Applicants will be interviewed next Thursday evening for the part-time position open. CPC – sign and billboard ordinance will go to public hearing. CAC – will be addressing large/small animal control at the next meeting. Library had open forum on October 28<sup>th</sup> to discuss new library site.

**Councilman Costello** – received *verbal* approval from Army Corps of Engineers regarding Glasco Mini-Park. Also, met with library committee at Town Hall site along with Greg Chorvas. Economic Committee will hold a meeting soon regarding Old Kings Highway corridor.
