#### **DEPARTMENT HEAD REPORT:**

Greg Chorvas – on-site parking at the Garlic Festival was recorded as the most cars parked ever, 1,726 cars. Ice Arena is projected to go above revenue.

## **MOTIONS & RESOLUTIONS:**

Motion made by Councilman Schirmer, seconded by Councilman Bruno to accept the resignation of John Livermore from the Water & Sewer Advisory Board.

Discussion: Councilman Schirmer said he is way too busy to continue, thank you for service.

Vote: Adopted - 5 Yes

Motion made by Councilman Bruno, seconded by Councilman Costello authorizing Superintendent of Highways, Douglas F. Myer to transfer the sum of \$74,158.17 from account DBO – 1-9-11 Fund Balance into account DBO – 3-9785.600 Installment Purchase Debt.

Discussion: Mr. Myer said this is an attempt to get 2017 budget down by paying off early.

Vote: Adopted – 5 Yes

Motion made by Councilman Bruno, seconded by Councilman Costello authorizing Superintendent of Highways, Douglas F. Myer to hire Ralph J. Butler as a part time "as needed" laborer for winter snow removal at a rate of \$15.00 per hour.

Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilman Bruno to accept the resignation of part time Police Officer Richard Carlson.

Vote: Adopted – 5 Yes

motion made by Councilman Costello, seconded by Councilman Bruno to accept the resignation of part time Police Officer Eric Cussick.

Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilman Bruno to approve a \$100.00 weekly stipend, effective immediately to Assistant Superintendent Keith Hartrum, which will bring said employee in line with others holding similar positions, along with similar duties, responsibilities and obligations related to the position, as per the recommendation of the Parks & Buildings Superintendent.

Discussion: Councilman Costello said there are three less people in the department and duties will be taken over by Keith, this will be a savings in the budget.

Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilman Bruno to approve adding to the Parks & Buildings Department part time call-out list, Patricia Wilbur at a rate of \$12.00/hour per the recommendation of the Parks & Buildings Superintendent.

Vote: Adopted – 5 Yes

Motion made by Supervisor Helsmoortel, seconded by Councilman Bruno to adjourn Town Board Meeting at 7:30 p.m., carried.
