PRIVILEGE OF FLOOR:

Michael Moriello, Attorney for Glasco Ponds – 47.4 acres proposed for project, presented maps with Rich Praetorius, Engineer. Also, discussed stormwater management options. Rich Praetorius completed the application to NYS DEC. Councilman Tucker suggested bringing this forward to the Water/Sewer Advisory Board for recommendation. All parcels are in the sewer district already. Stormwater issue is up to the Town Board, the law requires that it goes through a petitioning process and public hearings. Supervisor noted that they are setting up a meeting with Mr. Fischler from the county, which he highly recommends is homeowners association fails.

Historic Preservation Committee – Christina Plattner Evola presented the historic survey report to the town. Started project in 2003 after receiving grant of \$15,000.00, volunteers put in over 2,000 hours of labor. Thanked everyone for their hard work. Original will be in the Town Clerk's Office and a copy of the report will be in the Public Library.

PUBLIC COMMENT PERIOD:

Steven Haun – made point of assessment "errors" in the Town of Saugerties, SAGA has called for audit. Gave hand-outs including letter from District Attorney's Office. Feels that town needs a professional assessment.

Sally Depoala – resident for 28 years, owns property 2/3 around cul-de-sac; school bus parks illegally on side of road and double parked on side of road.

Elinor Trumpbour – thanked town board for support on Property Tax Reform Task Force. April 4th, attended Greene County Farm Bureau's meeting and attended School Board Meeting on April 5th asking support for this task force.

Councilwoman Thornton – League of Women Voters is hosting an open meeting on Tuesday, April 26, 2005 at 7:00 p.m. on how to grieve your assessment. The Town Board is not an unresponsive board. Real Property Task Force residents have an obligation to contact Senator Bonacic's Office.

Councilman Tucker – agrees with Councilman Costello and Councilwoman Thornton with feelings of board.

MOTIONS & RESOLUTIONS:

Motion made by Supervisor Helsmoortel, seconded by Councilman Macarille to accept the following Resolution authorize the posting of "No Thru Truck-Trailer and tractor trailer combination traffic – local deliveries only" on People's Road and Canoe Hill Road.

RESOLUTION DATED APRIL 20, 2005 TO PROHIBIT TRUCK TRAFFIC AND POST 'NO THRU TRAFFIC' SIGNS ON PEOPLES ROAD AND CANOE HILL ROAD IN THE TOWN OF SAUGERTIES

WHEREAS, the Highway Superintendent of the Town of Saugerties has determined the safety, configuration and characteristics of Peoples Road and Canoe Hill Road in the Town of Saugerties does not meet the criteria for continuous thru truck and tractor trailer traffic and should be used for local deliveries only; and

WHEREAS, a legal review of Section 1660(a) 10 and 17 of the Vehicle and Traffic Law offers the Town Board the ability to regulate and limit tractor-trailer and tractor-trailer combinations in excess of a combined weight of ten thousand pounds; and

WHEREAS, a "trailer" means every vehicle with or without motive power, designed for carrying persons or property and for being drawn by a motor vehicle and to constructed that no part of its weight rests upon the towing vehicle; and

WHEREAS, a "truck" means every motor vehicle which is designed, used or maintained primarily for the transportation of property; and

WHEREAS, the truck route limitations prescribed in this Resolution shall not apply to:

- (a) fire trucks or other emergency vehicles or vehicle on emergency business involved in the saving of life or property, or
- (b) implements of husbandry incidentally moved upon a road, or
- (c) road repair, construction or maintenance vehicles while involved in the repair, constructions or maintenance of road within the town.
- (d) local delivery vehicles, and so

NOW THEREFORE BE IT RESOLVED that the Town of Saugerties Highway Superintendent shall procure and have posted appropriate signs along the designated routes as required by the laws of the State; and

BE IT FURTHER RESOLVED that "No Thru Traffic Road – Local Deliveries Only" signs by posted on Peoples road and Canoe Hill Road with a maximum weight limit of 5 tons or more on each aforementioned road; and

BE IT FURTHER RESOLVED copies of this resolution will be forwarded to the Town of Saugerties Police Chief, Ulster County Sheriff's Department and New York State Police as notification and proof of the new road designation and limitations; and

BE IT FURTHER RESOLVED that this resolution is to take effect immediately upon installation of signage under the direction of the Highway Superintendent.
