# **PUBLIC COMMENT PERIOD:**

**Eric Tietjen** – wants sewer extended down through Kings Highway and even down Old Stage Road.

**Steve Hahn** – 216 Churchland Road resident – representing SAGA (Saugertisians Against Government Abuse) organization against Saugerties assessment and assessor's office; laws are being broken.

**Leonard Steinberg** – owned property in Saugerties since 2002. Spot assessing is illegal in New York State. The Review Board is a disgrace.

**Herve Senequiere** – mentioned several addresses and how much they are assessed and that they were spot assessed.

**Ms. Hirsch** – lived in Ulster County since 1966 and Saugerties for 8 years; her basement and attic are assessed.

**Josepha Gutelius** – lived in Saugerties 23 years and her assessment has tripled but she can not double rent on those apartments.

**Lois Freedman** (Steve Hahn spoke on her behalf) – house re-assessed in 2003 while no renovation or construction being done. Inequity between neighbors immoral and illegal.

#### **SUPERVISOR'S COMMENTS:**

Highway Superintendent Bernie Ellsworth has notified me that the town has received its CHIPS money – the amount is \$132,760.73. The town board appreciates the tremendous amount of time and paper work required by Bernie to see this money returned to the town for our road work.

We received a letter from Senator Bonacic on November 19 regarding the redirecting of traffic court fines to the State. The Senate has reversed the provision in the budget and the bill now goes to the Governor to be made law. We were encouraged by Senator Bonacic and the Association of Towns to immediately send a letter requesting that the Governor now sign this bill and the Town of Saugerties has done so. As soon as we know what the Governor does we will let you know.
