BOARD COMMITTEE REPORTS:

Councilman Schoonmaker – Animal Shelter will hold a fundraiser on November 1st at Little Blueberryy and Ohana.

Councilman Andreassen – attended the Veterans luncheon at Texas Roadhouse. Councilwoman Thornton – Touch-a-Truck event was held and very successful; so far \$7446.00 has been raised for the new playground. Lifespring started their fall class schedule today; CPC meets October 24; TV23 meets November 14; library has a therapy dog that you can read to on Wednesday's. Also, if you have time, take a look at Mt. Marion dam site, very interesting. Supervisor Costello added that you can check out the facebook page – growing up Mt. Marion. Councilman MacIsaac – attended public hearing with Delgado regarding broad band access; 26% of people do not have access to high speed internet. Supervisor Costello said that the county is interested in running a fiber optic network and people should take the poll on saugertiesbroadband.net – it's an important project. Councilman Andreassen said that there are people in fear of 5G and Supervisor Costello responded that 5G is a radio wave but fiber is not a stray energy.

MOTIONS & RESOLUTIONS:

Motion made by Councilman MacIsaac, seconded by Councilwoman Thornton to approve a curfew of 8:00 p.m. for Halloween, October 31, 2019 in the Town of Saugerties. Vote: Adopted – 4 Yes (Councilman MacIsaac voting no)

Motion made by Councilman Schoonmaker, seconded by Councilwoman Thornton to approve setting a public hearing date of November 6, 2019 at 6:00 p.m. pertaining to the 2020 Budget. Discussion: Supervisor Costello said that we will be within the cap. Vote: Adopted – 5 Yes

Motion made by Councilman Andreassen, seconded by Councilman Schoonmaker to approve moving part time Police Officer Sophie Epstein to a 90 day temp, full time position at a pay rate of \$22.69 per hour, effective October 17, 2019. Vote: Adopted – 5 Yes

Motion made by Councilwoman Thornton, seconded by Supervisor Costello to allow the supervisor to sign the Facility Decommissioning Plan, as on file, in regards to the ELP Myer Solar LLC Project.

Discussion: Supervisor Costello said that there needs to be some thought on what to do after usefulness is up. Councilman MacIsaac added that they may to able to replace more efficient equipment in 20 years' time.

Vote: Adopted – 5 Yes

Motion made by Supervisor Costello, seconded by Councilman Schoonmaker to approve the resolution, as on file, regarding Opposing the Danskammer Build Out Proposal. Discussion: Councilman Schoonmaker added that the proposal would like to make it a full time plant but air knows no boundaries. Councilman MacIsaac said that in a Climate Smart Community, we need to start somewhere. Councilman Andreassen said that this has little power but sends a message and Supervisor Costello added that we are going to be far ahead of green energy and supports resolution – grateful to Councilman Schoomaker for bringing this forward.

Vote: Adopted – 5 Yes

Motion made by Councilman MacIsaac, seconded by Supervisor Costello to award to the lowest written submitter Sullivan Fire Protection Corp., for the re-install of new fire suppression sprinklers, piping and related, in a new Ice Arena Hybrid Building, over all public assembly and access areas previously removed to accommodate demolition of existing structure, at a cost not to exceed \$25,000.00, as per the recommendation of the Ice Arena Director and Parks & Building Superintendent.

Discussion: Greg Chorvas added that the reinstall of fire suppression system is in the budget. Vote: Adopted – 5 Yes

Motion made by Councilman Schoonmaker, seconded by Councilwoman Thornton to authorize the Supervisor to sign a resolution naming October 20, 2019 as American Legion Day in the Town of Saugerties.

Vote: Adopted – 5 yes
