Over 50 skaters from Kiwanis will be competing in Lake Placid this weekend for Empire State Games. Councilman Costello extends best wishes to the skaters. Also, the police department computer up-grade is underway.

Councilman Bruno gave the Building Department monthly report. Also, attended a GIRO demo with the Supervisor, which takes garbage in at one end and creates power.

MOTIONS & RESOLUTIONS:

Motion made by Councilman Costello, seconded by Councilman Bruno to approve hiring Bob Hlavaty as a consultant on the Kings Highway East Light Solar Project at a rate of \$40.00 per hour.

Discussion: Councilman Costello said the town is exploring solar and Bob helped in the past. Supervisor Helsmoortel said that Central Hudson has agreed to lease the property, which will lower our cost. Councilman Schirmer said he opposes the motion, not the individual.

Vote: Adopted – 3 Yes (Councilman Schirmer voted No; Supervisor Helsmoortel abstained)

Motion made by Councilman Bruno, seconded by Councilman Costello to approve the revised Memorandum of Agreement (MOA), as on file, between the Town of Saugerties and the International Brotherhood of Teamsters Local Union No. 445.

Discussion: Supervisor Helsmoortel said that the department was going to break off on their own insurance but in the end decided against it.

Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilman Bruno to approve the Proposed Summer Recreation Program Registration Fees, on file, effective February 4, 2016 as per the recommendation of the Summer Recreation Program Director and the Parks & Building Superintendent.

Discussion: Greg Chorvas explained the actual cost per hour/week and it's very reasonable. Councilman Costello said this has been a financial strain for a while.

Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilman Bruno to approve the resignation of Dispatcher Christopher Worrad, effective January 27, 2016.

Vote: Adopted – 5 Yes

Motion made by Councilman Schirmer, seconded by Councilman Costello to approve the Justice AUP report, as on file, which was written by the town's accountant and was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants for the period of January 1, 2015 through December 31, 2015.

Vote: Adopted – 5 Yes

Motion made by Councilman Schirmer, seconded by Councilwoman Thornton to approve, as on file, the town board consent to dedication of water mains and sewer pump station from Donald G. Feistamel and Theresa J. Feistamel.

Discussion: Councilman Schirmer explained that this is the companion piece to road dedication, which was approved a few months ago.

Vote: Adopted – 5 Yes

Motion made by Councilwoman Thornton, seconded by Councilman Costello to approve Barton & Loguidice, DPC (B&L) assisting the Town of Saugerties with the completion of a 2015 NYSDEC

Catskill Park Smart Growth Implementation Grant application, as on file, for the Bristol Beach Park Improvements project.

Discussion: Councilman Costello added that this gives us the opportunity to apply for

\$75,000.00 grant. Vote: Adopted – 5 Yes

Motion made by Councilwoman Thornton, seconded by Councilman Bruno to allow the Supervisor to sign the Memorandum of Understanding (MOU), as on file, between the Town of Saugerties and Greenway for the Bristol Beach State Park – Access Improvements Feasibility Study.

Discussion: Councilwoman Thornton said this will look at bulkheads and potential access. Supervisor Helsmoortel said this is a fully funded grant.

Vote: Adopted – 5 Yes
