MOTIONS & RESOLUTIONS:

Motion made by Councilman Costello, seconded by Supervisor Helsmoortel to add to the ice arena part-time call out list Alene Woerthman at a rate of \$10.00 per hour, per the recommendation of the Ice Arena Director and the Parks & Buildings Superintendent.

Discussion: Councilman Costello added that Alene will help out as needed. Vote: Adopted – 4 Yes (Councilwoman Thornton absent)

Motion made by Supervisor Helsmoortel, seconded by Councilman Costello to hire Prudence Wagner as a part-time worker, as needed, at the town animal shelter at a rate of \$10.00 per hour, effective immediately, per the recommendation of the Animal Shelter Manager.

Motion made by Councilman Costello, seconded by Supervisor Helsmoortel to amend a motion from the October 21, 2009 Town Board meeting as to include the proper information to approve the purchase of a 2008 Ford Crown Victoria vehicle from Mark Gottenberg at a price of \$9,999.00 to be used as the new canine vehicle #780 per the recommendation of the Chief of Police.

Discussion: Councilman Costello stated that a new car would have been \$30,000.00; this car has 5,000 miles on it.

Vote: Adopted – 3 Yes (Councilwoman Thornton absent, Councilwoman Campbell abstained)

Motion made by Councilman Costello, seconded by Supervisor Helsmoortel to appoint Officer Christopher Schneider as a 90-day temp in the town police department to fill a vacancy due to a resignation at a rate of \$19.00 per hour, effective immediately, per the recommendation of the Chief of Police.

Vote: Adopted – 4 Yes (Councilwoman Thornton absent)

Motion made by Councilman Costello, seconded by Supervisor Helsmoortel to approve the new comprehensive Town Police Department Rules, Regulations and Instructions, per the recommendation of the Chief of Police, as on file.

Vote: Adopted – 4 Yes (Councilwoman Thornton absent)

Motion made by Supervisor Helsmoortel, seconded by Councilwoman Campbell to approve a 3% increase in salary for Greg Chorvas, Carolyn Maines and Alvah Weeks, retroactive to January 1, 2009.

Discussion: Supervisor added that these three department heads were in the non-union agreement and were taken out January 1, 2009 and never received a raise.

Vote: Adopted – 4 Yes (Councilwoman Thornton absent)

Motion made by Supervisor Helsmoortel, seconded by Councilman Costello to adjourn Town Board Meeting, carried.
