Whereas, a local law being proposed as Local Law No. 9 of 2007 has been introduced by a member of the Town of Saugerties Town Board to amend the Town of Saugerties Zoning Law as follows:

A Local Law Amending Local Law No. 3 of the Year 1989 entitled "Zoning Law, Town of Saugerties, New York".

Be it enacted by the Town Board of the Town of Saugerties, New York as follows:

SECTION I - AMENDMENT

That Local Law Amending Local Law No. 3 of the Year 1989 entitled "Zoning Law, Town of Saugerties, New York" is amended as follows:

to amend the provisions of the existing Zoning Law to incorporate all amendments to the Zoning Law together with the following which is annexed hereto and made a part hereof.

SECTION II - SEVERABILITY

If any clause, sentence, paragraph, section article or part of this local law shall be adjudicated in any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section, article or part thereof directly involved in the controversy in which such judgment shall have been rendered, and such invalidity shall not be deemed to affect the remaining portions thereof.

SECTION III - EFFECT OF AMENDMENT

Except as herein modified, Local Law No. 3 of the year 1989, and any subsequent valid amendments thereto, is hereby ratified and confirmed.

SECTION IV - EFFECTIVE DATE

This Local Law shall be effective as provided by law, upon filing and acceptance by the New York Secretary of State.

WHEREAS, the Board desires to hold public hearings with respect to the adoption of this local law;

NOW, THEREFORE, be it resolved that public hearings be held by this board with respect to the adoption of this proposed local law at 6:30 p.m. on November 13, 2007 at the Frank D. Greco Senior Citizens Building, Market Street, Saugerties, New York and at 6:30 p.m. on December 6, 2007 at the Frank D. Greco Senior Citizens Building, Market Street, Saugerties, New York; and it is further

RESOLVED, that the Town Clerk is hereby authorized and directed to cause public notice of the hearing to be given as provided by law.
