Motion made by Councilman Schoonmaker, seconded by Councilman Andreassen authorizing the bid of one (1) new 2019 or newer Dodge Ram 3500 Dual Rear Wheel Chassis w/ Model 5108DJ Utility Body (or equal) for the Water & Sewer Department as per the recommendation of Mark Resso.

Motion made by Councilman Andreasssen, seconded by Councilwoman Thornton to approve the low bid to Carl Bell, Plumbing & Heating for the installation of water meters in the Bluestone Park Water District for the amount of \$17,272.84. The bid award will be dependent upon the requisite insurances, bonds, etc as per the recommendation of Water & Wastewater Superintendent, Mark Resso.
