Councilwoman Thornton – Library auction will be November 12th; SAMA will be November 29th at 6:00 p.m. at the Sr. Center, everyone from Route 9W should attend. Historic Preservation Commission will have another Public Hearing on the Winston Farm on November 20th. Also, happy to report that nine people have responded to participate on the Bio-diversity.

Councilman Costello – Garlic Festival is an excellent event for the town and surrounding neighborhoods. Sgt. Drescher performed excellent police work at the festival to divert a situation in a prompt manner. Extend compliments to Terry, Kevin and Nancy for their work in the new offices.

Councilwoman Campbell – Saugerties Chambers of Commerce was able to secure an agricultural grant because of the Garlic Festival. EDC will work with the Village in applying for a quality community grant. Upper Hudson River Alliance has received \$25,000.00 for regional marketing. Thank you to Claudette Zinkow and Janice Ferraro for their help in the move to the new offices. On November 20th the Ethics Committee meeting will take place.
