Motion made by Councilman Costello, seconded by Supervisor Helsmoortel to allocate and dedicate, from undedicated funds in the Recreation Trust fund, an amount not to exceed \$25,000.00 for purchase of a used or reconditioned 100kw Emergency Backup Generator for the Chiller Plant, along with emergency lighting, at the Kiwanis Ice Arena, as per the recommendation of the Parks & Buildings Superintendent.

Discussion: Councilman Costello added that we don't have a back-up and we have been lucky so far. We have a responsibility to keep the ice sheet intact.

Discussion: Supervisor Helsmoortel added that NYS has adopted this and we need to do so also.

Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilman Bruno to approve the retirement of Police Sergeant Don Tucker, effective January 23, 2017.

Discussion: Councilman Costello said that Don is a wonderful person, appreciate his professional service to the community. Thank you!

Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilman Schirmer to allow the Supervisor to sign off on the 2017 DWI Task Force Agreement, as on file, between the Town of Saugerties and Ulster County per the request of the Police Chief.

Discussion: Councilman Costello said that this is done every year, the fines will off-set overtime.

Motion made by Councilman Costello, seconded by Councilman Schirmer to hire Reserve Police Officer Joseph Asprea as a part time police officer at an hourly rate of \$21.00, effective December 15, 2016 and per the request of the Police Chief.

Motion made by Councilman Costello, seconded by Councilman Schirmer to hire Reserve Police Officer Brian Levy as a part time police officer at an hourly rate of \$21.00, effective December 15, 2016 and per the request of the Police Chief.

Discussion: Councilman Costello said they were both reserve and part time is important part of staffing.

Motion made by Councilman Schirmer, seconded by Councilwoman Thornton to allow Mark Resso, Water & Sewer Department employee to carry over 10 vacation days to be used in 2017. Discussion: Councilman Schirmer added that Mark is acting superintendent and is required to be at water main breaks – we have had three within the past week.

Motion made by Councilman Bruno, seconded by Councilman Costello to approve the refund of recreational fees in the amount of \$2,400.00 to Joseph Mayone for his 2 lots of a 3 lot subdivision on Market Street in Glasco, NY.
