RESOLUTION BY SAUGERTIES TOWN BOARD TO INCREASE FEES FOR MAJOR SUBDIVISION APPLICATIONS

WHEREAS, the Town of Saugerties Town Board, pursuant to the Saugerties Town Code, has the authority to establish fees for each application of a subdivision duly authorized to be paid to the authorized town official, pursuant to Section 215-7(A) wherein the Town Board is duly authorized to assess such fees to be paid to said town official; and

WHEREAS, Section 117-1(B)(4) provides that fees are established or re-established for the following applications and services Planning Board applications (subdivision); and

WHEREAS, Section 117-2 of the Saugerties Town Code provides "the amounts of the fees for the applications and services listed above as well as other similar applications and services as set by the Town Board shall be as established from time to time by resolution of the Town Board"; and

WHEREAS, the Town Board has determined that with respect to major subdivisions, as defined in the Saugerties Town Code S215-8, it is in the public interest to have the fees increased to reflect the additional use of the Town of Saugerties public services including, but not limited to, the fire departments in the district where the major subdivision is to be located, and the town ambulance district;

NOW THEREFORE, be it;

RESOLVED that the application fees for major subdivision shall be increased by \$800.00 per lot or dwelling unit to be distributed equally for the fire district in which the major subdivision is to be situated and the Town ambulance district.

Discussion: Councilman Bruno said this is long overdue, glad to vote on it tonight.

Vote: Adopted – 5 Yes

Motion made by Supervisor Helsmoortel, seconded by Councilman Bruno to adjourn Town Board Meeting at 7:20 p.m., carried.
