Vote: Adopted – 4 Yes (Supervisor Helsmoortel absent)

Motion made by Councilwoman Thornton, seconded by Councilman Costello to approve the list of Summer Day Camp Staff, as submitted and on file, along with the waiting list and others related to department's summer staffing, as per the recommendation of the Recreation Sub-committee, Day Camp Director and Parks & Buildings Superintendent.

Discussion: Councilman Costello added that sign-up for camp is now going on at town hall.

Motion made by Councilman Bruno, seconded by Councilwoman Thornton to accept and award the bid for Road Sanding Materials, Abrasive Screenings-Washed, that was opened on April 29, 2010 to low bidder Peckham Materials Corp., bid price of \$11.50 per ton FOB, for the Town of Saugerties and the Village of Saugerties. Vote: Adopted – 4 Yes (Supervisor Helsmoortel absent)

Motion made by Councilman Bruno, seconded by Councilman Costello to approve the list, as on file, regarding the surplus equipment sale for the Highway Department, per the recommendation of the Highway Superintendent.

Discussion: Councilman Costello added that periodically there is out-dated equipment and can be sold.

Vote: Adopted – 4 Yes (Supervisor Helsmoortel absent)

Motion made by Councilman Costello, seconded by Councilman Leighton to approve the following, regarding the Police Consolidation SEQRA "Section 617.5c(7) of State Environmental Quality Review Act (SEQRA), classifies the "construction or expansion of a primary or accessory/appurtenant, non-residential structure or facility involving less than 4,000 square of gross floor area and not involving a change in zoning or a use variance and consistent with local use controls" as a Type II Action. Therefore, the Town of Saugerties determines that the expansion of the Town Police Department and Town Hall is a Type II Action and exempt from further review under SEQRA."

Discussion: Councilman Costello stated that part of Police Consolidation is to add a second floor to the department. Vote: Adopted – 4 Yes (Supervisor Helsmoortel absent)

Motion made by Councilman Costello, seconded by Councilman Leighton to approve the resolution, as on file, authorizing the Supervisor to engage in negotiations and discussions with the County of Ulster regarding shared services concerning county roads with the Town of Saugerties.

Discussion: Councilman Costello added that the county initiated and our accountant and highway superintendent are in favor of pursuing. Vote: Adopted – 4 Yes (Supervisor Helsmoortel absent)

Motion made by Councilman Costello, seconded by Councilman Leighton to adjourn Town Board Meeting, carried.
