Motion made by Councilman Costello, seconded by Councilwoman Campbell to approve the modified resolution (prior approval of said resolution was on August 12, 2009), as on file, regarding the CSXT Rail Utility Facility relating to Tissal Road and Kings Highway. Vote: Adopted – 4 Yes (Supervisor Helsmoortel absent)

Motion made by Councilwoman Thornton, seconded by Councilman Costello to set a public hearing date of Wednesday, November 4, 2009 at 6:00 p.m. regarding the Cold War Veterans Tax Exemption.

Vote: Adopted – 4 Yes (Supervisor Helsmoortel absent)

Motion made by Councilwoman Campbell, seconded by Councilman Leighton to approve amending the existing electrical inspection agencies list, as on file, per the recommendation of the Town of Saugerties Department of Safety and Buildings. Vote: Adopted – 4 Yes (Supervisor Helsmoortel absent)

Motion made by Councilwoman Campbell, seconded by Councilman Leighton to appoint Katie Blundell effective January 1, 2010 to replace Ellie Henkel as the Zoning Board Secretary at a rate of \$200.00 per month.

Discussion: Councilwoman Campbell added that the Zoning Board will miss Ellie greatly.
