PRIVILEGE OF FLOOR: Police Department to discuss K-9

Cpt. Steve Filak said that a K-9 presence is very important and is of no cost to the taxpayers, all the pieces to the puzzle are in place. One K-9 equals three police officers in the line of duty. Officer Rushkoski said a K-9 team is more effective and a deterrent when you take a drug dog into a school. He has been part of a K-9 team for several years and has seen the good that it does for the town. Officer Culver has 14 years of experience in training dogs and working with cadaver, trail, scent and drug dogs. She has seen the benefits of giving a family closure in finding loved ones. The police department wanted to come before the board to explain the need for keeping another K-9 unit in the department.

PUBLIC COMMENT PERIOD:

Bob Dederick – after the 4th of July parade, there was nothing to eat at Cantine Field. A good idea would have been to have food trucks and the traffic was unbearable. Also, if there is an increase in taxes for K-9, board should consider eliminating the position. Supervisor Costello said this was the first year that the Lions Organization took over July 4th and they will most likely consider expanding festivities.

Drew Wood – asked about digital road signs, are they legal or how can we get them legalized? Supervisor Costello said there was not a clear determination in previous discussion. Councilman Andreassen said to be patient, digital signs may become accessible for non-profits.

Arthur Green – pleased that the Town Board is taking an active part in up-dating the zoning on Kings Highway. There are too many vacant buildings; under-utilized piece of land.
