- Brian feels at odds because of the Use Variance and knowing the applicant cannot prove all 4 criteria. Henry said at the last meeting Mr. Fuller was told that and Jeanne agreed that Mr. Fuller was told that it would already be a problem because the area variance application states that if it is self-created the appeal can be denied.
- Jeanne also mentioned that Mr. George Redder stated to Mr. Fuller that the Greens Inn could request a zoning change with the Town Board.
