PUBLIC COMMENT:

Lanny Walter – would like to talk about gambling and No Saugerties Casino is still functioning, which he is the chairman of. Met Assemblyman Lopez, Senate Rep. Leader, Republicans and Democrats on the subject. Public referendum may be in the future. Amendment says there will be seven casinos – people need to pay attention.

Gaetana Ciarlante – attended Planning Board meeting last night and a business is interested in locating to Kings Highway but turned away to go before the ZBA for a variance because large pipes would need to be inside and a fence around the property. Too much regulation if we want businesses to come in.

Councilwoman Thornton – July 24th workshops with Lifespring; barn walls are going up on the Kiersted property on April 27th. April 25th there will be a Public Hearing on Water Resources at 6:30 p.m. and TV23 meets April 18th.

Doug Myer – award Callahan to go ahead and fix Tissal Road with fund balance money, pay-off Hemlock Lane drainage and absorb two retirement incentives, which is \$356,000.00 in total relief to taxpayers.

Chief Sinagra – gave first quarter report. Police Department received a grant for \$10,000.00 from TRACS. At the Stop DWI banquet Officer Hampel received an award for being first in number of arrests and Officer Tiernan was second. VIP meeting had 35 in attendance and starting to receive applications. Det. Sgt. car is leased at no costs to the taxpayers.

Councilman Bruno – owners of CVS plaza turned away Tractor Supply, didn't want to give up too many parking spaces. Donlon Town Hall sign is being worked on.

Greg Chorvas – Little League had their clean-up day with 31 volunteers = 167 volunteer hours. Opening Day is April 20^{th} . Collapsed sewer main has been replaced. The docks are in at the mini parks and Collegiate Regional 15 year old Babe Ruth will be held on May 4 and 5.

Discussion: Councilman Bruno said the new meters are guaranteed for 20 years and Supervisor Myers added that this is exciting technology.
