TOWN BOARD MEETING - SEPTEMBER 18, 2024

The Town Board Meeting was held on Wednesday, September 18, 2024 at 7:00 p.m. at the Frank D. Greco Multi Purpose Building located on the corner of Market and Robinson Streets in the Village of Saugerties. The meeting opened with the Pledge of Allegiance with the following members present:

PRIVLEGE OF FLOOR:

Citizens for a Beautiful Saugerties with a presentation on Regenerative Farming concept for Winston Farm by Andrew Faust – explained an alternative vision with a community farm and forest preserve and permaculture living trust. This land is a "community asset".

Diane Colello – large proportion of residents are rent burdened. Housing stability is precarious with rents being unreasonable and unattainable for many. Suggesting the town board opt-in to Good Cause Eviction

PUBLIC COMMENT PERIOD:

Brandon Shiller – it is a disgrace that the town board entertained the idea to give the privilege of floor to an outside group; we need this project to move forward.

Lauren Marcello Ruberg – appreciate the time and effort of presentation; feels like this other plan is not better but different. Should not be "us" against "you".

April Richers – thank you to the Supervisor and Adriana Beltrani (the Town Planner) for the presentation last week. The three developers are not greedy but have put a lot of time and money in to this project already.

Marc Brodkin – try to respect the place we have come from; town board is in the hot seat. Susan Murphy – tried to get brochures out to the public last Thursday, everyone should reflect to treat all with respect.

Dia Mansbach – country is littered with empty shopping malls, need open land that is properly maintained.

Sarah Vogwill – thank you to the board for hearing the presentation tonight.

Judith Spektor – need land for agriculture and we need food to sustain us. There is no way to produce new land.

Josepha Gutelius – already zoned to build on site at Winston Farm; interested if the town board will be voting on pro-housing motion.

Robert Schaaf – STR in abundance on Timberwall Road; tired of late night music and excessive parking on the side of roads. Something needs to be done.

Suzanne Bennett – on September 30 at 6:30 p.m. another discussion will be held at the Orpheum regarding a town and village grant for \$4.5 million; all are welcome.

SUPERVISOR'S COMMENTS:

We need to look at the Winston Farm project with open eyes; if we change the zoning, that is taking action. It is not zoned to remain as open space now.
