Motion made by Councilman Schoonmaker, seconded by Councilman Ivino to allow the supervisor to sign the proclamation, as on file, pertaining to standing against and rejecting inequalities.

PROCLAMATION

Therefore, I, Fred Costello, Jr., Supervisor of the Town of Saugerties and the following members of the Town Board, Leeanne Thornton, Michael Ivino, John Schoonmaker IV and Paul Andreassen, do hereby proclaim our commitment to an inclusive community effort that rejects all stigma and bias towards mankind. We urge all residents to join us in treating each other with respect and work together in these trying times to overcome all expressions of hate and bigotry. We make the pledge to only be involved in projects cleared of all color and gender bias and we will work to correct past actions that have had a negative impact on those of color.
