Motion made by Councilman MacIsaac, seconded by Councilman Andreassen to approve a temporary easement for the American Petoleum equipment and construction company environmental remediation program at the town of Saugerties Sunoco gas station on Old Route 32, a Town Road. Vote: Adopted – 5 Yes

Motion made by Councilman Schoonmaker, seconded by Councilman MacIsaac authorizing the Town Supervisor to sign an agreement with Central Hudson, granting an easement for any use relating to the electric, gas or communication industry, including but not limited to, the installation, operation and maintenance of overhead and/or underground electric, gas or communication facilities.
