Motion made by Councilman Costello, seconded by Councilman Leighton to approve the following salaries for Elected Officials for 2010: Town Supervisor \$35,000.00, Town Clerk \$39,599.00, Town Highway Superintendent \$53,258.00, Town Board Members (4) \$10,000.00 each, Receiver of Taxes \$37,758.00, Town Justice (2) \$26,250.00 each.

Motion made by Councilwoman Campbell, seconded by Councilman Costello to approve a salary of \$42,500.00 for the Town Planner for 2010.

Vote: Adopted – 4 Yes (Supervisor Helsmoortel absent)

Motion made by Councilwoman Thornton, seconded by Councilman Leighton to approve the 2009-2010 Highway Inventory of Equipment, as on file, per the recommendation of the Highway Superintendent.

Motion made by Councilman Leighton, seconded by Councilman Costello to approve the resolution, as on file, regarding the allowance of unused sick leave credits under Section 41(j) of the New York State Retirement and Social Security Law.
