DEPARTMENT HEAD REPORTS:

Doug Myer – there is 920' road done at Bristol Beach, we have made major progress. The 2020 year end at the Transfer Station is complete. We had 293 tons of recycling; organic recycling was 32 tons, an increase of 104%.

Greg Chorvas – Small World has been dismantled and some fence pickets have been requested and there is still some left. Wind fence and some trees did come down in the latest wind storm at Cantine. Summer Recreation has on-line sign ups. All fields should be open next week.

BOARD COMMITTEE REPORTS:

Councilwoman Nau – would like to thank the committee for a complete and thought-provoking police report.

Councilwoman Thornton – March 18 is the deadline for Boys & Girls fundraiser and they will have a virtual auction on May 21. Starting on April 23 through October on the 4th Friday of each month, there will be a community food bank at the Senior Center.

Councilman Ivino – we are closer to ground-breaking for the Animal Shelter. Patti Kelly will be acting chair of ZBA while Jeanne Goldberg is unable to.

Councilman Schoonmaker – HPC met and a couple markers have been requested; Esopus Creek releases with DEP; and Climate Task meets on March 18th.

Discussion: Dennis Larios explained that there have been problems with the Malden plant and this is an emergency order for equipment.

Motion made by Councilman Schoonmaker, seconded by Councilwoman Thornton to approve the resolution, as on file, supporting the return of adult in-patient behavioral health and detox units to the Mary's Avenue Campus of the Health Alliance Hospital of the Hudson Valley. Discussion: Chief Sinagra explained that this has been a major issue for families when moved out of Kingston. Councilman Ivino added that addiction and mental health issues hit community along with first responders.
