#### RESOLUTION

WHEREAS, the Town of Saugerties agrees to pay any costs associated with the change provided for herein; and

WHEREAS, the Town wishes to correct this error.

NOW, it is hereby resolved that:

1. The Town of Saugerties requests Assembly Bill 11270 be entered to authorize the enrollment of Police Officers KJ Swart and Christopher R. Helsmoortel into Retirement and Social Security Law 384(d) to be effective as soon as practicable.
