PRIVILEGE OF FLOOR:

Saugerties Community Youth Awards were presented by Mary Olsen with assistance from Councilwoman Thornton to the following area youth: Lauren Bacon, Shannon Averill, Avery Herzog, Christopher Magee and Robert Talmadge.

PUBLIC COMMENT PERIOD:

Josh Randall – vice chair of the Historic Preservation Commission and unanimous vote by committee to accept the road from Buffalo Road to Augusta Savage Road as historic. Complete comments are on file at the Town Clerk's office. Carrie Monroe – owns the same property, no improvements – how can the taxes be raised by \$1,400.00. Assessor Frank Orlando explained the process to grieve your assessment.

Neal Smoller – assessed on a building that does not exist. Assessment numbers have gone up in a recession when housing market is down. Seems like things are done from a desk and no one came out to actually look at the property.

Gaetana Ciarlante – fatal flaw in assessment. Ten years ago we were assessed at 100%. Suffolk County assessments have decreased, why haven't ours? Many new developments, why aren't the taxes going down?

Geraldine Spada – friendly Saugerties is not too friendly anymore.

Bianca Aponte – real estate broker; this was not the time to do a revaluation. Where are the comps for justification?

Tina Krein – in town for 30 years and property has had 62% raise with no improvements. Price of houses going down and spending still goes up.

Frank Orlando stated that 1/3 went up, 1/3 went down and 1/3 stayed the same on 9,500 parcels. This was a mass valuation. Working on building permits that were put on without being completed. Commercial questions would be referred to GAR.

Motion made by Councilwoman Thornton, seconded by Councilman Costello to approve the resolution, as on file, adopting Local Law #2 of 2010 regarding Open Space.

Discussion: Councilwoman Thornton explained that we are working under a grant, had three informational meetings with concerns raised at the last meeting and section was removed and appendix added regarding water resources. Vote: Adopted – 5 Yes
