Pre-Board Meeting – May 19, 2004

The Pre-Board Meeting of the Saugerties Town Board was held on May 19, 2004 at 6:00 p.m. at the Frank D. Greco Multi-Purpose Building at the corner of Market and Robinson Streets, in the Village of Saugerties with the following members present:

The following was discussed:

Councilman Tucker – rumor of dissolving Police Department; discussion of whether or not there should be a resolution to dispel rumor. Officers Fallon and Helsmoortel were also there for their input in the matter.

Greg Chorvas, Superintendent of Parks & Recreation – Jaycee Field had extensive vandalism and damage over the weekend, dangerous situation; bike jumps should be leveled. This area is not sanctioned by the town. Town Clerk safe will be moved to the private bathroom area; fixtures will be removed and we will use stand-alone shelving. The fixtures will be stored in the warehouse to be put back if circumstances change. The door will be replaced with a steel door and we will look into a dry chemical suppression unit. The bathroom past the bookkeeper's office will now be an "employee only" restroom. Also, Darin Smith is not able to work any longer and would like to replace him with Dan Koegel who will work maintenance during the summer.

Councilman Tucker – Tissal Road – testing needs to be done on all three properties, we need permission from all three, questioned if it was worth it, or wait. Also, read from the site assessment, "...TEAM recommends that the Town of Saugerties obtain legally binding "indemnification" from both NES and American Candle with regards to any contamination or environmental issues that may exist within the boundaries of the subject property caused by their operations." "TEAM was informed that the American Candle facility has been closed and the property is now up for sale. In addition, American Candle may have retracted its agreement with the Town of Saugerties to convey their property portion needed for the relocation project. These recent events have put the acquisition of this portion of the roadbed in question. Also in jeopardy is receipt of environmental indemnification from American Candle and gaining 'right of entry' to perform a sampling investigation on this property."

Motion made by Councilman Tucker, seconded by Councilman Costello to accept with regret the letter of resignation of full-time Police Officer Phil Fredenberg effective July 1, 2004 and to appoint Phil Fredenberg as a part-time police officer at a rate of \$13.50 per hour

Motion made by Councilman Costello, seconded by Supervisor Helsmoortel that Greg Helsmoortel, the Supervisor of the Town of Saugerties, is hereby authorized and directed to file an application for funds from the New York State Office of Parks, Recreation and Historic Preservation in accordance with the provisions of title 9 of the Environmental Protection Act of 1993 or title 3 of the Clean Water/Clean Air Bond Act, in an amount not to exceed \$350,000.00 and upon approval of said request to enter into and execute a Project Agreement with the state for such financial assistance to the Town of Saugerties for the development of a Skate Park facility.

Motion made by Councilwoman Thornton, seconded by Councilman Macarille to authorize the Supervisor to enter into agreement with Miller Environmental Group, Inc., of New Windsor, New York to perform geological sampling and analysis in conjunction with the Tissal Road relocation project at a cost estimated to be \$17,475.00, pending approval of the town's attorney review of the contract.

Motion made by Councilman Costello, seconded by Supervisor Helsmoortel to promote Barry E. Mower from temporary full time status to permanent full time status, effective June 1, 2004, subject to six (6) month probationary period, at a rate of \$12.51 per hour, as per the approved "entry level pay scale" in the non-union Memorandum of Agreement, as per the recommendation of the Parks and Buildings Superintendent.

Resolution made by Councilman Macarille, seconded by Supervisor Helsmoortel, as follows:

WHEREAS, in the event of a disaster, many communities do not have enough sufficiently trained Code Enforcement Officials to inspect buildings affected by such disaster; and

WHEREAS, Codes Division, in partnership with the New York State Building Official Conference, has a program to render volunteer assistance to disaster stricken communities known as CEDAR (Code Enforcement Disaster Assistance Response); and

WHEREAS, the Town of Saugerties supports the CEDAR program and supports the participation in the program by code enforcement officials employed by the City who meet the qualifications of CEDAR; and

NOW THEREFORE BE IT RESOLVED, that Code Enforcement Officer Paul Andreassen, and Assistant Code Enforcement Officer Alvah Weeks are authorized to submit application for membership to the Code Enforcement Disaster Assistance Response program and to complete the necessary training; and

BE IT FURTHER RESOLVED, that the Town of Saugerties agrees to provide indemnification and insurance coverage for said Code Enforcement personnel while acting as part of the CEDAR Team for mutual aid purposes.

WHEREAS, the supervisor and the town board wish to express our support for the present structure of the Saugerties Police Department, which is meeting the needs of our citizens; and

WHEREAS, the town board of the Town of Saugerties wishes to dispel and put to rest any and all rumors with regard to any disbandment and/or possible mergers with any other neighboring municipalities or other police enforcement agencies; and so

NOW THEREFORE BE IT RESOLVED that the Town board of the Town of Saugerties wishes to proclaim that it has no intent now, nor in the foreseeable future to dissolve the Town of Saugerties police department and will continue to support its own staffed full time police force,

RESOLUTION TO INCREASE BAG FEES AND IMPLEMENT PRE-PAID BAG SYSTEM DATED MAY 19, 2004

WHEREAS, Local Law No. 1 of the year 1990 authorizes the Town Board, from time to time, to establish by resolution a fee schedule for the privilege of disposing of garbage, trash and refuse at the Town Transfer Station, formerly the Town Sanitary Landfill Site, and

WHEREAS, the Town Board desires to increase the user bag fee from \$2.00 per bag to \$3.00 per bag and to implement a pre-paid bag system,

NOW, THEREFORE, BE IT RESOLVED, by the Town Board that the user bag fee be increased from \$2.00 per bag to \$3.00 per bag and that a pre-paid bag system be established, and it is

FURTHER RESOLVED, that these changes be effective retroactive to May 4, 2004.

Discussion: Councilman Macarille indicated increase is necessitated by labor costs, RRA costs, freon costs and this is the first increase in 14 years. Supervisor Helsmoortel noted that RRA confirmed their fuel costs have gone up considerably.
