Councilman Costello – Malden Mini Park was vandalized recently, picnic tables and Eagle Project destroyed and a resident's personal motor home was destroyed by fire. Glasco Mini Park will open on April 18, 2009. Read letter from Ulster Greene ARC for our police department's care and concern given regarding an attack on one of their

patients. The Summer Day Camp will be changing since state aid is unlikely; fees will be increased and will try to keep it affordable to families.

Councilwoman Campbell – March 28th there will be a balloon test for a cell tower at Centerville Fire Department. Saugerties may be getting a "green" cemetery on Kelly Road. Read letter from Mt. Marion Fire Department complimenting Alvah Weeks from the Building Inspector's Office. Quadricentennial up-date: Joy and Dick Moore will be hosting a Dutch artist for the month of September.

Motion made by Councilwoman Thornton, seconded by Councilman Costello to approve the lease between Town of Saugerties and the Library pending approval of Town Attorney, George Redder. This lease would be effective June 1, 2009 and run for eighteen months.
