Motion made by Councilwoman Campbell, seconded by Supervisor Helsmoortel to approve the hiring of Kathleen Blundell as a substitute part-time Clerk in the Town of Saugerties Building Department at a rate of \$9.50 per hour, effective immediately.

Discussion: Councilwoman Campbell explained Katie will be able to help catch-up on paperwork.

Be it resolved that Local Law #2 of 2007 entitled "a Local Law enacting a Temporary Moratorium, on building permits, special use permits and site plan review with respect to lands located on Canoe Hill Road, Mike Kraut Road, Washington Avenue Ext. and Route 9W North in the Town of Saugerties" be and it hereby is introduced before the Town Board of the Town of Saugerties in the County of Ulster and State of New York, and

Be it further resolved that copies of the aforesaid proposed Local Law be laid upon the desk of each member of the Town Board, and

Be it further resolved, that the Town Board hold Public Hearings on said proposed Local Law no less than fifteen (15) days apart, at the Frank D. Greco Senior Citizens Center, Robinson Street in the Village of Saugerties, New York at 5:30 p.m. on December 20, 2006 and at 6:00 p.m. on January 17, 2007, and

Be it further resolved, that the Town Board publish or cause to be published public notices in the official newspaper of the Town of the Public Hearings, at least ten (10) Days prior thereto, and

Be it further resolved, that the proposed Local Law be referred to the Town of Saugerties Planning Board and the Ulster County Planning Board for a report and recommendations in accordance with the provisions of the Town Law, General Municipal Law and Town of Saugerties Zoning Law, at least thirty (30) days prior to the conduct of the public hearings, and

Be it further resolved that the Town Clerk transmit written notice of the proposed Local Law to adjacent municipalities in accordance with Town Law and Town of Saugerties Zoning Law, at least ten (10) days prior to the date of the public hearings.

RESOLUTION DATED THE $15^{\rm TH}$ DAY OF NOVEMBER 2006 FORMALLY ADOPTING A "NO CASH" POLICY AT THE TOWN OF SAUGERTIES TRANSFER STATION

WHEREAS, the Town of Saugerties operates a Transfer Station on Route 212 in the Town of Saugerties which accepts garbage, trash, refuse and recyclables from those possessing a proper permit; and

WHEREAS, the Town of Saugerties charges a fee for the dumping of garbage, trash and refuse at the Transfer Station; and

WHEREAS, the Transfer Station is not equipped to accept cash in payment of the fees applicable to the use of the Transfer Station, but does accept payment by check or credit/debit cards; and

WHEREAS, the Transfer Station fees, including but not limited to the purchase of garbage bags, may be paid in cash at the Town Clerk's Office located at Town Hall, 4 High Street, Saugerties, New York; and

WHEREAS the Town Board wishes to formalize its policy adopted back in September of 2004 to not accept cash at the Town of Saugerties Transfer Station, which policy is necessary to protect the taxpayers and residents of the Town of Saugerties and others and to promote their benefit and welfare.

NOW, THEREFORE, be it

RESOLVED, by the Town Board of the Town of Saugerties that effective immediately no cash shall be accepted at the Town of Saugerties Transfer Station for any or all of the fees applicable to the use of the Transfer Station, including but not limited to the purchase of garbage bags and the disposal of garbage, trash, and refuse at the Transfer Station; and it is further

RESOLVED, that payment at the Transfer Station in the form of a good and sufficient check or a credit/debit card shall be acceptable.
