TOWN BOARD MEETING – JUNE 7, 2006

The Town Board Meeting was held on Wednesday, June 7, 2006 at 7:00 p.m. at the Frank D. Greco Multi-Purpose Building located on the corner of Market and Robinson Streets in the Village of Saugerties. The meeting was opened with the Pledge of Allegiance with the following in attendance:

ABSENT: Councilwoman Nancy Campbell

PRIVILEGE OF FLOOR:

Mark Anderson – Code Compliance Officer with NYS, Regional Rep. for this area – State is making changes to international codes (in 2003) to tailor them to NYS, changes coming again to codes. Must inspect buildings of public assembly at least once per year. A Certificate of Compliance has become a more important document. Municipalities have more work to do and fees will probably increase.

Kelly Redl-Hardisty – Guardian Self Storage co-owner – explained what avenues they were exploring to try and dry out property. Property will need to be abandoned and taken down if not able to explore this last effort. Would like 30-60 days additional time to remedy this situation. Supervisor Helsmoortel responded that this would not be possible.

PUBLIC COMMENT PERIOD:

Michael Schaefer – problem with transfer station not accepting cash, every other place takes cash. Supervisor Helsmoortel responded that we had Public Hearings and this was a Town Board decision. Mr. Schaefer would like to know which stores carry the yellow garbage bags.

SUPERVISOR'S COMMENTS:

Supervisor Helsmoortel read the following letter from Senator John J. Bonacic:

My office has been contacted by individuals indicating that at a recent Town Board meeting, it was asserted that my office suggested the hiring of Vernon Benjamin to undertake certain grant paperwork.

I would appreciate it if you would clarify the record to reflect that my office did not suggest hiring Mr. Benjamin or any person to handle grant paperwork. I am pleased, as a State Senator, to have helped secure significant funding for Saugerties for everything from infrastructure to education initiatives. However, I never recommend the hiring of any particular individual or firm to handle the grant paperwork associated with those funds because I believe that is strictly a local decision.

This should not be construed to read as my having any problem with the hiring of Mr. Benjamin, I simply do not want the record to reflect that I recommended or suggested it.

I would like to comment on my statement at the April 1, 2006 Saugerties Town Board meeting having to do with the letter I just read.

I must have totally misinterpreted what the Senator's Office said to me and I apologize to the Town Board for this misunderstanding.

Saugerties Economic Development Committee

Structure:

The committee will report to the Town Board and members will be appointed by the Town Board and will serve at its pleasure. The committee will be comprised of a minimum of 8 members, maximum 11. Beginning in 2007, terms of appointment shall be 3 years, with initial terms staggered so that each year at least one term expires. The committee will elect its own chairperson.

Mission Statement

The Saugerties Economic Development Committee (EDC) recognizes and values the many economic, social artistic and recreational benefits of the enterprises in our midst.

To promote the economic health of the community, the Saugerties EDC commits itself as follows:

- To monitor and assist the well-being of our Town and Village businesses and their employees
- To encourage interaction between businesses and community
- To attract new business

To accomplish these goals, the EDC will:

- Encourage and support infrastructure developments and improvements for new and existing business
- Help new business navigate the town permitting process
- Address zoning and planning needs that may arise

Glasco Sewer District: raise rate from \$4.40/1000 gal to \$4.94/1000 gal Glasco Water District: raise rate from \$3.67/1000 gal to \$4.74/1000 gal Malden Water District: raise rate from \$4.32/1000 gal to \$4.46/1000 gal

Vote: Adopted – 4 Yes (Councilwoman Campbell absent)

Motion made by Councilman Costello, seconded by Councilwoman Thornton to compensate Derek Debrosky, as a Transfer Station Attendant, at the Town of Saugerties Transfer Station at a rate of \$10.00 per hour as per the CWA Contract, for services provided since May 25, 2006.
