## Meeting Minutes

## C. Open Issues

> Public Hearings Scheduled - Opus 40 and Kaatsbaan Church

#### **Opus 40**

SBL - 28.001-5-10

- There was discussion about the Parks Service having designated Lot 10.
- Barry declared a correction to the Public Hearing Advertisement which was printed as Lot 9. Lot 9 has the house on it. The owner of house (Lot 9) is not in favor of having the house designated.
- It was suggested that in the future we (the commission) may want to expand the designation, but not at this time.

Barry moved that the public hearing be closed and made a motion to designate Section 28.001 Block 5 Lot 10 going into Opus 40 quarry. Josh Seconded.

## Kaatsbaan Church

Church – SBL – 8.4-6-1 Parish House – SBL 8.4-6-4

- Barry received a letter that the organ does not qualify for a grant.
- Barry showed pictures of stained glass window that was moved to the parish house.
- Reference was made to property description but the Section, Block and Lot number couldn't be located during the meeting.
