Motion made by Councilman Costello, seconded by Councilwoman Thornton to accept the Bus Shelter Agreement, as read, between the Town of Saugerties and The Birches.

# BUS SHELTER AGREEMENT BETWEEN TOWN OF SAUGERTIES AND THE BIRCHES

THIS AGREEMENT, made the 18<sup>th</sup> day of October, 2006, by and between the Town of Saugerties, a Municipal Corporation, having its offices located at Town Hall, 4 High Street, Saugerties, New York, 12477, hereinafter referred to as "MUNICIPALITY" and THE BIRCHES, a Not-for-Profit Corporation, having its office located at Route 9W, Saugerties, New York, hereinafter referred to as "BIRCHES", agree as follows:

WHEREAS, the Town of Saugerties has entered into a Bus Shelter Agreement with the County of Ulster dated October 18, 2006; and

WHEREAS, the County presently operates a public transit system, consisting of deviated fixed routes throughout Ulster County, including ingress and egress to the municipalities; and

WHEREAS, the County and the Municipality decided to enhance the public transportation services, improve passenger safety and convenience through the installation of bus shelters within the Municipality; and

WHEREAS, the BIRCHES, A Not-for-Profit Corporation, desires to have a bus shelter placed on its property to afford its residents access to the Ulster County public transit system; and

WHEREAS, the Town of Saugerties gives its consent to the placement of a bus shelter on the BIRCHES premises and that the town consents to same so long as said structure complies with all town, federal, state and local ordinances and regulations;

NOW, THEREFORE, in consideration of the covenants herein set forth, it is mutually agreed, memorialized and understood by and between the MUNICIPALITY and the BIRCHES as follows:

- 1. The MUNICIPALITY shall give the bus shelter and its components to the BIRCHES.
- 2. The BIRCHES, upon receipt of the shelter and its components, shall erect the bus shelters in mutually agreed upon and designated locations in accordance with the manufacturer's guidelines and, with the consent of the County of Ulster.
- 3. The BIRCHES agrees to keep the bus shelters clean and repaired.
- 4. The County may lease one end of each shelter for advertising at some point in the future. All ads will be approved by the County and the MUNICIPALITY. Any proceeds from the advertising will be used to support public transit in the community.
- 5. The BIRCHES will indemnify and hold the MUNICIPALITY harmless for all transactions occurring on said bus routes, including personal injuries, property damage and any other liability.

Motion made by Supervisor Helsmoortel, seconded by Councilman Costello to schedule a Public Hearing for the proposed 2007 Budget for November 1, 2006 at 6:00 p.m. Vote: Adopted – 5 Yes

Motion made by Councilwoman Campbell, seconded by Councilman Costello to schedule one (1) Public Hearing on November 15, 2006 at 6:00 p.m. for Local Law #3 regarding increasing the fees for the Building Department, Town Planning Board, Town Zoning Board of Appeals and the Town Board (Application for Zoning Change) in the Town of Saugerties.

Discussion: Councilwoman Campbell stated that at a meeting the fees were calculated on what it costs to get the job done. Councilman Costello added that increase in rec fee is supported by the Recreation Committee.

Vote: Adopted – 5 Yes

Motion made by Councilwoman Thornton, seconded by Supervisor Helsmoortel to authorize Building and Grounds Superintendent Greg Chorvas to gather cost estimates to proceed with the renovations to Public Access Lighthouse TV 23 offices as discussed with the committee.

Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilwoman Campbell to authorize the Town of Saugerties Supervisor, Greg Helsmoortel to submit an application and proposed feasibility study to the Shared Municipal Services Incentive Grant Program for the 2006-2007 Program Year pertaining to the Town of Saugerties Police Department and Highway Department.

Discussion: Supervisor Helsmoortel stated that in applying for the grant to do a study on monetary savings with shared village/town police and highway departments

Vote: Adopted – 5 Yes

Motion made by Supervisor Helsmoortel, seconded by Councilman Costello to adjourn Town Board Meeting, carried.
