Susan Puretz stated that if the Town Board turns down a designation, a reason has to be given based on findings and/or evidence. Barry Benepe suggested it was because the owners are not in favor of it. Supervisor Helsmoortel said discussing Winston Farm was not the purpose of this meeting.

Councilman Bruno asked for clarification regarding owners not wanting designation. Josh said that the owners would attend the hearings and give proof as to why designation should not happen and the commission may still approve.

PRIVILEGE OF FLOOR:

Infingy Engineering came to speak regarding a communications tower on Barclay Lane. Currently, there is no contract, just here tonight on informational purposes. Would like to build a stealth tower on water tank property owned by the Town of Saugerties. One hundred foot tower could not be seen except at the middle of Barclay Lane. Supervisor Helsmoortel said a site test would be done if this moves forward. Resident Patti Kelly asked if the tower could be seen from the water and is there trouble now with cell service. Water analysis was handed out and said that this would not be so much for cell but a competitive company to run cable and high speed internet. Resident Sal Misasi is concerned about blasting.

PUBLIC COMMENT PERIOD:

Tom Macarille – In 1986 a problem started with a culvert at Twin Maples and it is continuing. We are losing back yards because of erosion of gully. Culvert should have had a retention pond and dam. In 1989 the town approved 1200' of roadway and the Highway Superintendent has promised to have this done; excavators can fit because he has had equipment back there and easements are signed. We need the boards help, it is a mess and getting worse. Supervisor Helsmoortel talked to Bernie Ellsworth yesterday and he said it would take about two weeks and will hire part-timers to get the job done.

Discussion: Supervisor Helsmoortel added that when the dump was closed and capped, 12 wells were contaminated and now 3-4 homes can be taken off testing.
