The following topics were discussed:

Ralph Mayone – it has been one month since first approached board and nothing has been done about water at Guardian Storage, Route 9W. Councilman Macarille was the only member at a meeting with DEC. Councilman Macarille is waiting for a letter from Brinnier & Larios for solutions. Supervisor Helsmoortel said building department should be able to force Guardian Storage to do something – Order of Remedy Immediately. Supervisor Helsmoortel will talk to Paul Andreassen tomorrow.

Cafaldo Park Residents – handed Town Board petition to allow a Public Hearing regarding Inflight, Inc. They are concerned with increased traffic, home values decreasing, safety issues and possible congestion.

Lisa Stanley, Town Clerk – two representatives from FEMA gave information on how residents can call for flood assistance, this information will be put on Public Access and in our two local papers. Also, accepted an award from the Girl Scout's for the town's support in their organization, the certificate will hang in the Town Hall.

Greg Chorvas – looking for support from the Town Board on getting bids for three projects. Town Board all in agreement to move forward. Councilman Macarille stated landfill barn needs electric/heat in smaller rooms. Drainage and black top work should be moved along also. There is some cost savings by doing in-house and jointly with Village. Bernie Ellsworth wants to dig some test holes next week.

Summer Day Camp fees should be increased to \$50.00 per child with a maximum of \$95.00 per family.

Ernie Fick Memorial set for June 4th. Would like \$5,000.00 from recreation trust fund for memorial on field #5.

Malden Mini Park dock damaged, needs to be revamped. Looking into new design with different materials. Approximately \$4,000.00, which could be taken from recreation trust fund.

PRIVILEGE OF THE FLOOR:

Gil Hales – Bike Trail up-date – brochures are complete and ready to be handed out. Idea started with Gil and Mike Harkavy with support of Village and Town Boards to hire grant writer. Gil read the resolution that was passed by Ulster County Legislature using county roads in bike route. Thanked everyone who helped in making this possible.

PUBLIC COMMENT PERIOD:

Alan Greczynski and Charles Lantz – asking Town Board to raise limit for Veteran's exemption from \$120,000.00 to \$180,000.00. Please consider resolution and date for a Public Hearing.

James Bruno – not disputing inaccuracies in assessments but what are the motives of Mr. Haun's statements; why are the same properties brought up time and time again.

Steven Haun – Assessor is supposed to be full market value for 2004 and 2005; he gives the same examples because he hasn't received any answers.

Herve Senequier – SAGA is only focusing on assessment problem and still waiting to hear from elected officials as to what will be done. Unequal assessment is illegal in New York State.

Leonard Steinberg – on April 6, 2005 he struck a compromise and agreement instead of going to trial about his assessment. Mr. Greco forwarded letter changing the terms and stated different outcome. SAGA wants Town Board to establish equality for all.

Marjorie Greenberg-Vaughn – Public Comment period should be changed to have some feedback from the Town Board to the public.

Joe Roberti, Jr. – in 2003 Senator Bonacic gave money to be distributed to youth programs; wondered when this money will be distributed.

Bill Scala – questioned assessment on home. FOIL request to Assessor's Office for comparables in trying to find out how they came up with assessment figure. Received letter from John Greco in answer to FOIL; he just wanted to look at comparables in the office. Also, concerned with zoning in the town and taking large parcels off the tax rolls.

Vince Hackett – the fact that the Town Board wrote a letter through the town attorney was wrong. John Greco is a great lawyer, he has been my personal lawyer but believes it is a conflict of interest for John Greco to be attorney for town.

Carmine Tortarelli – spoke on assessment of his home that is higher than larger homes on Washington Avenue.

Marti Randall – people that speak before the board, would like a response. Everyone is frustrated with assessment, HITS and impending casino. Tired of "private meetings" being held.

Josh Randall – had previously asked for dialogue at these meetings back in March. Casino brings out addictions. More public informational meetings need to be held. We want dialogue.

RESOLUTION DATED THE 4TH DAY OF MAY, 2005 AUTHORIZING THE SETTLEMENT OF A PENDING ACTION FOR ALLEGED VIOLATIONS OF THE PUBLIC EMPLOYEE SAFETY AND HEALTH ACT AT THE TOWN OF SAUGERTIES LANDFILL (TRANSFER STATION)

WHEREAS, on August 10, 2004 the State of New York, Department of Labor, Division of Safety and Health issued an order and final billing to the Saugerties Town Landfill assessing a penalty of \$114,330.00 for alleged violations of the Public Employee Safety and Health Act at the Town of Saugerties Landfill (Transfer Station); and

WHEREAS, counsel for the Department of Labor has indicated that the Department may be willing to accept the sum of \$42,100.00 in full satisfaction of all outstanding matters pertaining to alleged violations at the Town of Saugerties Landfill (Transfer Station).

NOW, THEREFORE, be it

RESOLVED by the Town Board of the Town of Saugerties that the sum of \$42,100.00 be offered to the State of New York, Department of Labor, Division of Safety and Health in full payment and satisfaction of any and all penalties for alleged violations of the Public Employee Safety and Health Act at the Town of Saugerties Landfill (Transfer Station); and it is further

RESOLVED, that John J. Greco, Esq., as attorney for the Town of Saugerties convey this settlement proposal to the counsel for the State of New York, Department of Labor; and it is further

RESOLVED, that the Supervisor of the Town of Saugerties be and he hereby is authorized to execute any and all documents on behalf of the Town of Saugerties necessary to effectuate a full and final settlement of the alleged violations of the Town of Saugerties Landfill (Transfer Station) and a discontinuance of the pending legal action before the Industrial Board of Appeals in accordance with the terms of this resolution.
