PUBLIC COMMENT PERIOD:

James Fowler - wanted to state facts as a matter of record about his property at 2674 Route 9W in Saugerties, hamlet of Glenerie. He has lived there since 1998 and has had a number of problems with neighbor. He believes that the Building Inspector issued a permit in error and wants an investigation; there was no site review done. In February of this year, vehicle in driveway was fire bombed and then a windshield smashed. Also, the Police Chief needs to send patrols down to the Glenerie area. Councilwoman Thornton questioned if the police investigated the fire bomb. Mr. Fowler replied that the NYS Police were called.

DEPARTMENT HEARD REPORTS:

Greg Chorvas – final 10 yards of concrete was poured at Glasco Mini Park. Glasco Fire Department gave a tremendous amount of help to accomplish this goal. The Keeley/Lorenz field renovations are complete as well as grandstand roof, generator and roof repair. The Toddler Town playground will have a see-saw installed in the spring. The Open House will be held this Saturday, December 2, 2006 for the new town offices.

BOARD COMMITTEE REPORTS:

Councilman Leighton – Wayne Debrosky and Councilman Leighton spent the last two days attending a seminar put on by the DEC regarding wastewater. Topics discussed included establishing a 5 + year plan and a capital fund for districts.

Councilwoman Thornton – on December 18th at 7:00 pm there will be a Historic Preservation meeting; CPC meetings with Pat Fitzsimmons is holding sub-committee meetings four times a month, work should be done by the end of December. Biodiversity committee has been started. Cable Access will have their first live broadcast during the Open House on Saturday. Supervisor Helsmoortel commented that Channel 23 has improved tremendously and looks great.

Councilman Costello – recently went to permanent shifts in Police Department for the last two weeks; although the laptop grant has been suspended for the time being. Sgt. Scheffel put in a lot of time and effort for our emergency management plan and the County commented that Town of Saugerties was one of three communities to complete this task.

Councilwoman Campbell – the second Ethics Committee meeting will be December 13th at 6:30 p.m. in the new conference room. EDC has office space in the new addition with the Planning Board and Zoning Board. GIS summary is available for public viewing, which is 88 pages long.

MOTIONS & RESOLUTIONS:

Motion made by Supervisor Helsmoortel, seconded by Councilman Costello to allow Bernie Ellsworth Town of Saugerties Highway Superintendent, to go to bid to remedy road damage due to a drainage issue located in Malden, New York on Riverside Drive and River Road per the specifications of the Town Engineer.

Vote: Adopted – 5 Yes

Motion made by Supervisor Helsmoortel, seconded by Councilman Costello to allow Bernie Ellsworth Town of Saugerties Highway Superintendent to go to bid for a new tractor, a flail highway mower, for the Town Highway Department and to have the bid opening in January 2007.

Vote: Adopted – 5 Yes

Motion made by Supervisor Helsmoortel, seconded by Councilman Costello to approve the hiring of Sue Filak as a part time employee in the Town Tax Office at an hourly rate of \$9.50 per hour, effective immediately.

Vote: Adopted - 5 Yes

Motion made by Councilwoman Thornton, seconded by Supervisor Helsmoortel to adopt the updated Administrative Plan for the Section 8 Tenant Based Program which is also known as the Housing Choice Voucher Program by Carolyn Maines of the Town of Saugerties Public Housing Agency per the request of the NY Field Office.

Discussion: Carolyn Maines informed the board that this explains how they operate on a \$1,039,000.00 budget.

Vote: Adopted – 5 Yes

Motion made by Councilwoman Thornton, seconded by Councilman Leighton to authorize the Biodiversity Committee to undertake a biodiversity assessment of town property. This committee will have the authority to participate in training presented by Hudsonia and that will enable them to identify local biodiversity resource habitats and incorporate strategies for protection into land use planning.

Vote: Adopted - 5 Yes

Motion made by Councilwoman Thornton, seconded by Supervisor Helsmoortel to authorize the application for Certified Local Government Status with the National Park Service and State Historic Preservation Office as recommended by the Historic Preservation Commission.

Vote: Adopted – 5 Yes

Motion made by Councilwoman Campbell, seconded by Councilman Costello to approve the following resolution adopting Local Law #3 of 2006 for Increasing the Fees for the Town of Saugerties Building Department, Planning Board, Zoning Board and Town Board (for Zoning Changes).

Discussion: Councilwoman Campbell stated there only needed to be one Public Hearing for this topic.

Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Supervisor Helsmoortel to reapprove the resolution for the resubmission of the Greenway Trails Grant for the Glasco Riverfront Park per the request of the grant writing firm Shingebiss Associates, Inc.

Vote: Adopted – 5 Yes

Motion made by Supervisor Helsmoortel, seconded by Councilman Leighton to adjourn the Town Board meeting, carried.
