PUBLIC COMMENT PERIOD:

Ron LeBlanc – very excited to hear two board members, namely: Supervisor Helsmoortel and Councilman Costello, witnessed the Governor's speech. Can not believe in state of austerity budget with the school district, vacant homes and people leaving town, that the Town Board would consider buying Opus 40. NYS can not afford

to run parks, other parks and golf courses are closing. Don't think our community is large enough to support Opus 40 as a venue and the town should not be in the real estate business.

Mike Catalinotto, Sr. – on April 5, 1811 the Town of Saugerties was incorporated – needs to be celebrated.
