Motion made by Councilwoman Thornton, seconded by Supervisor Costello to approve hiring attorney Bruce Huttner from the firm of Burke, Scolamiero & Hurd, LLP at a billing rate of \$225.00 per hour to defend the Town of Saugerties due to a lawsuit filed by Tarpon Tower/Verizon Wireless against the town.

Discussion: Supervisor Costello added that they have been trying to put a cell tower in Mt.

Marion; ZBA did not grant a variance.

Vote: Adopted – 5 Yes

Motion made by Supervisor Costello, seconded by Councilman Ivino to approve the resolution pertaining to the Town of Saugerties Animal Shelter Project: State Environmental Quality Review Act – Lead Agency Determination which will be available upon request.

Discussion: Supervisor Costello clarified that this will be constructed on town property.

Motion made by Councilman Ivino, seconded by Councilwoman Thornton to approve the resolution, as on file, regarding the Kings Highway Water-Sewer Extension Project.

Vote: Adopted – 5 Yes

Motion made by Councilman Horton, seconded by Supervisor Costello to allow the supervisor to sign the Letter of Agreement, as on file, regarding the Birches.

Discussion: Supervisor Costello added that this is being purchased by a new group.

Vote: Adopted – 5 Yes

Motion made by Councilwoman Nau, seconded by Supervisor Costello to set a public hearing date of March 16, 2022 at 6:00 p.m. regarding amending Chapter 190 of the Town of Saugerties Municipal Code entitled "Sewers".

Discussion: Supervisor Costello explained that this is being done because of inconsistent language in the by laws.

Vote: Adopted – 5 Yes
