George Heidcamp – speaking as President of PBA regarding Contract negotiations. Union filed IP against town, agreed upon that town and union resolve. Judge ordered union back to the table. Teamsters wrote letter withdrawing illegal items; PBA is not the problem for not getting back to the table. Asking town board to pass a resolution so we can get back to the table. Does not want politics involved. Negotiations will start back up on Friday.

Current DARE officer does not want to continue.

Questioned why Bill Wallens named George Heidcamp as possible disciplinary action against him in a letter.

May need Executive Session next meeting regarding personnel matter, if not resolved.

Greg Chorvas – Ernie Fick Memorial is complete, although materials are over by \$2,987.00. Ken Benson donated a great deal of time. The dedication will be on September 17, 2005 at 11:30 a.m.

Moving forth with estimates with warehouse renovations.

At the Highway Department while shallow well work was being done, found all pipes are disintegrating in the ground and electrical wiring was ripped out of red building.

Recommending Senior Center Building not be used for concerts anymore.

Councilman Macarille added that he was at the Highway Department recently and the bathrooms were backing up, it was a mess. Possibly put up \$200,000.00 BAN to fix Highway Department and critical issues with animal shelter.

Daniel Riozzi – Inflight purchasing home on Riozzi Court – it's a private road, not maintained by the town, not the right neighborhood. Residents did not receive enough notification, concerned about saturation of these types of home in the town. Request extension so a Public Hearing could be held. Concerned that valuation of homes drop approximately 30% in neighborhood. Submitted a petition for the town board from neighbors.

Steve Costello – added to Inflight discussion that these facilities do not pay taxes, how much can town support?

Nancy Campbell – Saugerties is part of Upper Hudson River Alliance and this past weekend the Artist Tour was held with 26 artists participating. It was an outstanding success. Some artists experienced 200 visitors to their studio.

Thanked Carolyn Maines for a wonderful presentation at the Birches groundbreaking ceremony. *Esopus*

Councilman Costello –impressed with Public Access' new equipment and thanked Leeanne for efforts. Compliment Little League, Babe Ruth and Girl's Softball on a successful season. James Harris' did a wonderful job on his Eagle Scout Project revitalizing Jaycee Field. First new water bills went out, some went up and some went down. Malden is the only area left that is billed by units, not usage. Past January tax bill there was no fee of \$208.00, now it is on the water bill.
