Joe R.: State will not send the kind of letter Jeanne is looking for. Usually the state will send guidelines and let you know what you can not do.

Henry: In going through the definition word by word it appears Win One for Jesus does fit residential care facility.

In a letter from Mr. Mahon it states "the program focus is to provide a transitional home for women who have completed a drug, alcohol, a substance abuse program and not women actively treating for drug, substance or alcohol abuse. The further focus of the program is to provide support and guidelines to women concerning family and domestic abuse issues. Moreover, the program provides support and guidance to women concerning life skills training. This is not, strictly speaking, job training and vocational rehabilitation services."

Based on this description of the program provided by Win One for Jesus' attorney Mr. Richard Mahon and all the other evidence reviewed A motion was made by Joe R. seconded by Brian that Win One For Jesus meets the definition stated in the Town of Saugerties Zoning Law as a residential care facility and the determination of the Code Enforcement Officer is affirmed.
