MOTIONS & RESOLUTIONS:

Motion made by Councilman Ivino, seconded by Councilman Schoonmaker to increase Planning Board Secretary Becky Bertorelli's salary to \$20.00 per hour, effective October 20, 2021. Ingrassia as a full time Motor Equipment Operator at a rate of \$23.09 per hour effective November 8, 2021. Discussion: Doug Myer said that highway has two openings and both individuals have worked for similar departments.

Gambichler, Jr., as a full time Motor Equipment Operator at a rate of \$23.09 per hour effective November 15, 2021. Vote: Adopted – 5 Yes Motion made by Councilwoman Thornton, seconded by Supervisor Costello to allow the supervisor to apply the NYSERDA Grant to the purchase of an electric vehicle for the police department.

Discussion: Supervisor Costello said that he is confident that we can subsidize to make it worth it.

Vote: Adopted – 5 Yes

Motion made by Supervisor Costello, seconded by Councilwoman Thornton to enter into Executive Session for matters pertaining to Labor Contract negotiations at 9:19 p.m., carried.
