Allen and/or Dawud B. Rivera as a part time "as needed" laborer for winter snow removal at a rate of \$17.00 per hour. Vote: Adopted – 4 Yes

Motion made by Councilwoman Thornton, seconded by Supervisor Costello to approve Peg Nau as a member of the town board to fill the balance of the term vacated on September 2, 2020. Discussion: Supervisor Costello said that Peg is our former Tax Collector and ran the department in a bypartisan way; she is a very valuable member for the board. Councilman Schoonmaker thanked everyone who applied for the position. Councilwoman Thornton extended her congratulations to Peg and Councilman Ivino welcomed Peg and is looking forward to working together.

Motion made by Supervisor Costello, seconded by Councilman Schoonmaker to adjourn town board meeting at 8:11 p.m., carried.
