Motion made by Councilman Ivino, seconded by Supervisor Costello to add to the Ice Arena's part time call out list Skylar Sprance at a rate of \$19.00/hour as per the recommendation of the Ice Arena Director and the Parks & Buildings Superintendent.

Vote: Adopted – 5 Yes

Motion made by Councilman Horton, seconded by Supervisor Costello to declare surplus and no longer of use to the Town of Saugerties one (1) 2001 Stone Champion Concrete Mixer, Model #65CM, Serial # 252003252, as per the recommendation of the Parks & Buildings Superintendent.

Vote: Adopted – 5 Yes

Motion made by Councilwoman Nau, seconded by Councilman Horton to dispose of the aforementioned Concrete Mixer via the most revenue producing means, which may include Metal Salvage Reclamation, as per the recommendation of the Parks & Buildings Superintendent.

Vote: Adopted – 5 Yes

Motion made by Councilwoman Thornton, seconded by Councilman Horton to declare surplus and no longer of use to the Town of Saugerties twenty-five (25) 1500w Metal Halie Sports Field light fixtures, along with eight (8) cross members, from West Field #7, as per the recommendation of the Parks & Buildings Superintendent.

Vote: Adopted – 5 Yes

Motion made by Supervisor Costello, seconded by Councilman Horton to donate to Saugerties Little League the required number of aforementioned field lighting fixtures and cross members to upgrade their field lighting on Sauer Field #1, as per the recommendation of the Parks & Buildings Superintendent.

Discussion: Greg Chorvas said they were approached to upgrade and this will address liability.

Vote: Adopted - 5 Yes

Motion made by Councilman Ivino, seconded by Councilman Horton to dispose of remaining aforementioned fixtures via the most revenue producing means, which may include Metal Salvage Reclamation, as per the recommendation of the Parks & Buildings Superintendent.

Vote: Adopted – 5 Yes

Motion made by Councilman Horton, seconded by Councilwoman Thornton to authorize the Parks & Buildings Department to advertise for sealed bids for the purchase and install of an Inclusive Playground System, along with Rubberized poured-in-place Safety Surface, in reference to the combined Senate and Assembly's JayCee Field Grant, as per the recommendation of the Parks & Buildings Superintendent.

Discussion: Supervisor Costello said the surface will seem expensive but it will pay for itself in no time.

Vote: Adopted – 5 Yes

Motion made by Councilwoman Nau, seconded by Councilman Horton to authorize the Parks & Buildings Department to advertise for sealed bids for the install of a new full court (size) asphalt Basketball Court, along with option for the excavation and removal of the existing Basketball Court at JayCee Field in reference to the combined Senate and Assembly's JayCee Field Grant, as per the recommendation of the Parks & Buildings Superintendent.

Vote: Adopted – 5 Yes

Motion made by Councilwoman Thornton, seconded by Councilman Horton to appoint Lou Klepner as the regular representative for the Town of Saugerties on the Ulster County Planning Board from January 1, 2026 through December 31, 2029.

Discussion: Councilwoman Thornton added that he is a member of Ulster County transportation committee and Town/Village STAC, very active and engaged member.

Vote: Adopted – 5 Yes

Motion made by Councilman Ivino, seconded by Councilman Horton to approve the resolution, as on file, in opposition to the discharge of contaminated water into the Hudson River.

Discussion: Councilman Ivino clarified that "Save the Hudson Law" was overturned by a Judge's ruling. How can unclear waste be okay, it has no business being in the waterway.

Vote: Adopted – 5 Yes
