TOWN BOARD MEETING – OCTOBER 1, 2025

The Town Board meeting was held on Wednesday, October 1, 2025 at 7:00 p.m. at the Frank D. Greco Multi-Purpose Building located on the corner of Market and Robinson Streets in the Village of Saugerties. The meeting opened with the Pledge of Allegiance with the following members present:

PRIVILEGE OF FLOOR:

Russell Urban-Mead, VP – Hydrogeology Department Manager with Labella Associates spoke about Winston Farm water testing. Attorney Mike Moriello said that the public hearings are over and they will not answer questions tonight from anyone other than town board members. Mr. Urban-Mead has been working in the Hudson Valley for thirty years and he noted that there is nothing uniform about the Winston Farm site. They ran the test for 35 days; the bed rock well is 150' deep and it produced 50 gal/min. The back valley well produced 220 gal/min with no water coming out of the Beaverkill; the tests were not conducted during a wet period and state protocols were in place.

PUBLIC COMMENT PERIOD:

Kenneth Devine – was this privilege of floor in response to all the comments that were filed and will the request be granted.

Paul Rubin, Hydro Quest – submitted two reports to the board, which are on file.

Janet Asiain – web ex can not hear; also, didn't know you could request that comments not be added.

Yves Mikol – new, good information and test was done in February; would like to know what the level is now.

Kathy Nolan, Catskill Mountainkeeper – nothing would limit to 220 gal/min and understands that this is a connected aquifer. Drought is real. The town board does not have to be constrained and should keep learning.

Joanna Weber – appreciates comments by Paul Rubin and we need to be very careful about protecting water sources.

Gaetana Ciarlante – questioned the motion on denial of appeal for FOIL.

Bill Barr – water is a precious resource, there was a time where the Blue Mountain Reservoir was extremely low.

Randolph Horner – resident of Woodstock but Saugerties is a part of the town; pumping task reveals that it is a fragile resource. We are in stage one of a drought now.

Marc Brodkin – it would be a shame if the town board did not hear from other professionals regarding this topic.

Kathy Gordon – pleased to listen to hydrologist report but what is the effect on all of Saugerties.

SUPERVISOR'S COMMENTS:

A lot of work and meetings were held for zero waste at the Garlic Festival; appreciate Councilman Ivino for all hard work and UCRRA's role in this.
