Councilwoman Thornton – TV23 is exchanging locally produced shows, look for some new shows. Community bike ride will be held on August 29th. Lifespring has 185 enrolled for the upcoming sessions. Library Budget vote will be September 3rd at the library and there are three board positions open.

Councilman Costello – police department hosted DWI task force over the weekend with NYS Police and UC Sherriff. The ice rink is starting their season. Would like to compliment the Supervisor and Councilman Bruno for their efforts with economic development in our town.

Councilman Bruno – met with the exec from Solite to discuss extending natural gas down Kings Highway.

Motion made by Councilman Bruno, seconded Councilman Schirmer to allow the Zoning Board of Appeals to reimburse Mrs. Bruce Dedrick \$200.00 of application fees that were collected pertaining to Five D Enterprises, Inc., at 441 Malden Turnpike, Saugerties. Discussion: Councilman Bruno added that it was an error that they went before the ZBA. Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Supervisor Helsmoortel to increase the salary of School Crossing Guard Edward Kime from \$12.25 to \$14.00 per hour, effective September 1, 2015 and per the recommendation of the Chief of Police. Discussion: Councilman Costello added that it is hard to find quality people because they have to be available in the morning and afternoon for a short amount of time. Vote: Adopted – 5 Yes

Motion made by Councilman Costello, seconded by Councilman Bruno to increase the salary of School Crossing Guard Walter O'Connor from \$12.25 to \$14.00 per hour, effective September 1, 2015 and per the recommendation of the Chief of Police. Vote: Adopted – 5 Yes

Motion made by Councilman Schirmer, seconded by Councilwoman Thornton to increase the salary of Water & Sewer Department employee Michele Haines from \$15.30 to \$15.80 per hour, effective August 1, 2015.

Discussion: Councilman Schirmer added that this raise is in relation to Michele doing on-line courses in small water maintenance.

Vote: Adopted – 5 Yes

Motion made by Councilman Schirmer, seconded by Councilwoman Thornton to increase the salary of Water & Sewer Department employee Kyle Hummer from \$13.20 to \$15.00 per hour, effective August 1, 2015.

Discussion: Councilman Schirmer added that probation period is over and can cover weekends and also completed courses.

Motion made by Councilman Schirmer, seconded by Councilwoman Thornton to approve the resolution, as on file, setting water rates in the Bluestone Park Water District. Vote: Adopted – 5 Yes

Motion made by Councilman Schirmer, seconded by Councilwoman Thornton to approve the resolution, as on file, authorizing creation of and improvements to the Bluestone Park Water District of the town, estimating the aggregate cost thereof to be \$135,000.00; appropriating said amount therefore and authorizing the issuance of \$135,000.00 bonds of the town to finance a portion of said cost.

Motion made by Councilman Schirmer, seconded by Councilwoman Thornton to approve the justice corrective action plan, as on file, which was written by the town's accountant and pertains to the audit done by the NYS Comptroller's Office of the justice court operation. Vote: Adopted – 5 Yes

Motion made by Councilwoman Thornton, seconded by Councilman Bruno to approve the resolution, as on file, approving request for proposals for solar power net metering credit purchase agreement and directing invitation of bids. Vote: Adopted – 5 Yes

Motion made by Councilman Schirmer, seconded by Councilman Bruno to approve the resolution, as on file, approving purchase of an easement and right-of-way from Karl J. Pietkiewicz and Mary Elizabeth Pietkiewicz for the benefit of the Town of Saugerties, o/b/o the Glasco Water District.

Discussion: Councilman Schirmer explained that this is for the water tank project and it protects the town of the Pietkiewicz's; the money is to cover legal expenses. Vote: Adopted – 5 Yes

Motion made by Councilman Schirmer, seconded by Councilman Bruno to award the bid for an aluminum vacuum septic tank and related accessories for the Water & Sewer Department to Amthor Welding Truck Body Equipment Specialists, 20 Osprey Lane, Gardiner, NY. Vote: Adopted – 5 Yes

Motion made by Councilwoman Thornton, seconded by Councilman Schirmer to set two (2) public hearings regarding the zoning law pertaining to solar energy generating facilities, which will be held on October 7, 2015 at 6:00 p.m. and October 22, 2015 at 6:00 p.m. at the senior center.
