Motion made by Councilman MacIsaac, seconded by Councilman Schoonmaker to approve a 50 cent raise for Jeanne Sutton, part-time clerk for the tax receiver, making her hourly rate \$14.50, effective January 1, 2018.

Motion made by Councilman Schoonmaker, seconded by Councilman Andreassen to approve a 50 cent raise for Anastasia Redman, part-time clerk for TV23, making her hourly rate \$16.50, effective January 1, 2018.

Vote: Adopted – 4 Yes (Supervisor Costello absent)

Motion made by Councilman Schoonmaker, seconded by Councilman MacIsaac to appoint Marjorie Block to the Tourism Committee for 2018. Vote: Adopted – 4 Yes (Supervisor Costello absent)

Motion made by Councilman Andreassen, seconded by Councilman MacIsaac to appoint Marjorie Block as the Chair of the Tourism Committee for 2018. Vote: Adopted – 4 Yes (Supervisor Costello absent)

Motion made by Councilman MacIsaac, seconded by Councilman Andreassen to appoint Gary Bischoff to the STAC (Saugerties Transportation Advisory Council) for 2018.

Discussion: Councilwoman Thornton added the town and village committee meets the 4th Tuesdays of the month, lively discussions. Councilman MacIsaac said Gary is a great guy, he will be a good asset.

Vote: Adopted – 4 Yes (Supervisor Costello absent)

Motion made by Councilman Andreassen, seconded by Councilman Schoonmaker to authorize the attorney for the Town of Saugerties, John J. Greco, to file, commence and prosecute on behalf of the Town of Saugerties a legal action in the Supreme Court of the State of New York, County of Ulster, against Douglas Weeks, Gregg Weeks and Gregg S. Weeks, as Trustee of the Douglas F. Weeks Irrevocable Trust with respect to the unlawful construction and operation of a sawmill and related structures on premises located at 186 Patch Road in the Town of Saugerties, Ulster County, New York.

Discussion: Councilman Andreassen added that the sawmill was moved from the original spot and grew with buildings. A stop work order was issued.

Vote: Adopted – 4 Yes (Supervisor Costello absent)

Motion made by Councilman MacIsaac, seconded by Councilman Andreassen to award the bid of December 4, 2017 for the demolition of 508 York Street, Malden, NY (SBL #18.10-3-15) to Ray Mayone Construction, Inc., PO Box 125, Glasco, NY in the amount of \$27,240.00 and an additional amount of \$1,175.00 for a required asbestos survey. The total cost for such removal to be assessed against the land on which the structure is located. Vote: Adopted – 4 Yes (Supervisor Costello absent)

Motion made by Councilman Andreassen, seconded by Councilman Schoonmaker to authorize Legacy Building and Project Design Consultants to perform a Structural Analysis, Overstress Report and Upgrade Design, to include detailed justifications for replacing versus repairing, along with life expectancy of existing membrane covering and new replacements, for the Kiwanis Ice Arena, in an amount not to exceed \$8,500.00, as per the recommendation of the Ice Arena Director and the Parks & Buildings Superintendent. Vote: Adopted – 4 Yes (Supervisor Costello absent)

Motion made by Councilman Schoonmaker, seconded by Councilman Andreassen to approve participant registration fees for the Summer Youth Recreation Program, on file, for the 2018 summer program, as per the recommendation of the Summer Youth Recreation Program Director and the Parks & Buildings Superintendent. Vote: Adopted – 4 Yes (Supervisor Costello absent)

Motion made by Councilwoman Thornton, seconded by Councilman MacIsaac to adjourn town board meeting at 5:50 p.m., carried.
