1. SANDRA GAVE LEEANNE A COPY OF TOX MAP THAT REPORTED CHEMICAL WASTE FROM SEVERAL SITES IN THE TOWN. LEEANNE WILL GIVE THIS PAPER TO JEREMY. THE WEB SITE IS :

2. DISCUSSION ON THE DRAFT LETTER FROM BEHAN PLANNING AND DESIGN THAT LEEANNE AND JEREMY CONTRIBUTED INPUT. 3. DISCUSSION ON THE FORMATION OF A COMPREHENSIVE PLAN STEERING COMMITTEE: OF THESE PRESENT, JOSH RANDALL SAID HE WOULD BE GLAD TO BE ON IT. THE VILLAGE WAS ALSO TO BE REPRESENTED.
4. LAST MONTHS MINUTES CHANGES: SPIDER WAS NOT ABSENT, BUT CAME IN LATER, AND THE GROUP AGREED THAT THE WATER RESOURCE WATER LIST WAS VOTED TO BE ADDED AS AN APPENDIX TO THE OPEN SPACE PLAN.
5. IT WAS DECIDED THAT BEHAN'S BILL OF \$2,504.95 WAS HIGH AND JOSH 'S RECOMMENDATION THAT ONLY \$2,000 BE PAID, 2ND BY SPIDER. THIS WAS APPROVED. THERE WAS DUPLICATION OF SERVICE.
6. DISCUSSION ON THE NUMBER OF HARD COPIES THAT WERE TO BE PROVIDED BY BEHAN FOR THE OPEN SPACE PLAN. LEEANNE WAS TO LOOK INTO OTHER METHODS OF MAKING HARD COPIES AND ALSO DISK COPIES.
