Building permit is required either way and it would be about half for Planning Board to deal with. Definitions need to be looked at.

PRIVILEGE OF FLOOR:

Assessor Frank Orlando explained that the office has been committed to maintaining 100% assessment since 2010; properties this year increased by 17% generally.

PUBLIC COMMENT PERIOD:

Harry Vickery - speed limit on Route 212 is 55 mph, which makes it dangerous to move farm equipment; 55 is too fast, people are passing on the left and right of vehicles.

Mark Hofstatter – Blue Stone Park Water District will be reaching out to DEC and Department of state; looking into attaching some type of filtration.

Chris Giordano – a concern with STR is the inspection process; can't build anything now with all the laws in place.

Peg Krom – speed on Route 212 is excessive and unsafe with busses dismissing children.

Lou Klepner – appreciates the motion on the agenda regarding Route 212 speed limit changes throughout the stretch on 212; should be consistent with 40/45 mph.

Mark Kanter – speeding on Route 212 is not a new problem, it has just gotten worse; would like to see between 40-45 mph.

Robin Blier – Route 212 has had multiple accidents and numerous animals have been killed.

Animal Shelter fundraiser is planned for May 7, 2022. Thank you to Nicole Roskos for her help with the recent tree plantings.
